

Activities of Municipal Corporation, Amritsar during the month of July, 2015 and in the coming near future.

I) <u>CIVIL ENGINEERING DEPTT</u>. :-

- 2 Nos. Meeting attended at Delhi for approval of HRIDAY Project, SWM
- 128 Nos. Dwelling Units have been allotted to the Urban Poor under BSUP scheme & possession also delivered.

• <u>CITY BUS SERVICE:</u>

60 Nos. Busses have been purchased & put on road under NUTP scheme.

• SOLID WASTE MANAGEMENT

The bids for SWM project for Amritsar cluster were received. Only one bidder M/s Essel Infra Project Limited, Mumbai has been declared as qualified. Financial bid submitted by the company has been opened on 28/7/15 and the same is under consideration.

• TRUCK STAND SCHEME

Road works have been executed in the truck Stand scheme with the total Expenditure of Rs 2.90 Cr. out of 5.69 Cr. The Remaining work is in progress.

• HRIDAY SCHEME

The Ministry of urban development, Government of India has sanctioned Rs. 69.31 Cr. under HRIDAY project for Amritsar.

• DEVELOPMENT OF FILTH DEPOT (DUMP) AT BHAGTAWALA AND FATAHPUR

The work for construction of approach road leading to Filth Depot Bhagtawala has been completed. Earth work has been done on the remaining approach road (Pvt land). The work for construction of boundary wall around the filth depot is in progress.

• HUDCO LOAN

Development works in various parts of City amounting to Rs. 1828.08 lacs have been approved from HUDCO under Scheme 20393 & most of the works have been completed. Total Expenditure is 612.45 Lacs. Remaining work is in progress.

• RAM BAGH GARDEN

The inauguration stone has been laid by the Hon'ble Local Govt. Minister on for the installation of dancing fountain in the historical Ram Bagh Garden.

• PMIDF-HUDCO SCHEME NO.19967 (RESTORATION OF ROAD ETC.)

Rs. 121.06 have been spent on the roads, where PWSSB has laid sewer as well as water supply lines under the JICA Project in different parts of the city.

• DEVELOPMENT WORKS IN CIVIL DEPTT.

During the month of June 2015, various development works were completed. The total Expenditure is Rs. 11.69 Lacs.

IV) <u>LAND DEPARTMENT</u>:-

Achievements of Land Department during the month of July 2015.

The Land department of Municipal Corporation, Amritsar has constituted two teams under the supervision of inspectors for the removal of temporary encroachments from foot paths and roads. Other than dealing with the complaints received in the department, these teams remove temporary encroachments from the different parts of the city. Removal of encroachments is an on going process and is being under taken on daily basis.

Also, shopkeepers in the markets are being regularly requested through public address systems to keep their merchandise/goods within their shops/ premises and not to display them on roads/ footpaths. Other than daily removal of encroachments from different parts of the city, some major tasks were executed on Majitha Road, Circular road and Railway road during the month who's photographs are as below.
