## Amendments in Outdoor Advertisement policy/documents.

Department of Local Government vide memo no CTP(LG)-2018/953 dated Subject:-21.03.2018 notified Outdoor Advertisement Policy and Outdoor Advertisement Byelaws vide memo no CTP(LG)-2018/1309 dated 26.04.2018. Thereafter subsequent instructions were also issued by the Department regarding allotment of Advertisement Rights for outdoor media devices and Outdoor Advertisement tender documents.

A meeting was held under the Chairmanship of Hon'ble Minister, Department of Local Government, Punjab on 07-04-2021 in Municipal Bhawan, Chandigarh to deliberate upon the issues pointed out by the Commissioners of many ULBs regarding certain clauses in the Advertisement tender documents; due to which the tenders are not being successful. This meeting was attended by the Principal Secretary Local Government, Joint Director Local Government, Mayor Ludhiana, Jalandhar, Chairman Improvement Trust Ludhiana, Amritsar, Patiala, Jalandhar, Commissioners, Ludhiana, Amritsar, Jalandhar, Patiala, Bathinda and Regional Deputy Directors Ludhiana, Jalandhar, Patiala, Ferozpur.

After the detail deliberation the Government has decided to allow the following amendments in the instructions and conditions for the outdoor advertisement tender:-

No.	Sr. no. 15 of General terms and conditions of instruction dated 18.03.2018 issued by Local Government:  The successful bidder will submit a Bank Guarantee as per 2.8 in favour of Municipal Corporation, Ludhiana as security which shall remain valid till the enforcement of Agreement alongwith refundable security equal to 3 months of the bid amount, which shall be adjusted alongwith EMD at the end of the tenure. The successful bidder shall pay monthly advance to Municipal Corporation, Ludhiana the OMD charges before 10 <sup>th</sup> of every month.	EMD and Refundable Security should be immediately adjusted or returned on receip of Bank Guarantee.
